- 1. <u>Call meeting to order flag salute</u>: Rob Elliott called the Selectmen's Meeting to order with a flag salute at 6:00pm.
- 2. <u>Board Member Attendance Recognized</u>: Present: Rob Elliott, Jim Burrill, Rodney Cook, and Dick Worthley. Andy Pratt arrived 6:13pm. Others Attending: Sandra Mitchell and Betsy DuBois.
- **3.** Approval of the Selectmen's Meeting Minutes from 10/27/2020: Jim B. made a motion to approve minutes from the 10/27/2020 selectmen's meeting. Dick Worthley 2nd the motion and all voted in favor (4-0).
- 4. <u>Approval of the Treasurer's Warrant for week of 11/12/2020 for \$20,023.95:</u> Dick W. made a motion to approve Treasurer's Warrant for week of 11/12/2020 for \$20,023.95.Jim B. 2nd the motion and all voted in favor.
